

APPLICATION REQUIREMENTS

Applicants must be current college students or recent graduates of an Arkansas college or university, or Arkansas high school graduates currently attending or recently graduated from an out-of-state college. Candidates should have a strong interest in attending law school and intend to take the LSAT this year. **Items Required for Application Consideration:**

- 1. Completed application.
- 2. Write a letter to the selection committee, maximum 500 words, detailing the applicant's motivation for pursuing a career in the legal field. <u>Additionally</u>, choose one of the following essay questions to address:
 - a. What challenges or obstacles have you overcome and what have you learned from those experiences.
 - b. Describe a challenge or barrier you've faced in your pursuit of legal education and how you navigated it. What did you learn from the experience?
 - c. Tell us about a time you successfully achieved a goal, outline the specific steps you took to reach it.
 - d. Describe a facet of your identity, background or personal story that shapes who you are.
- 3. Transcript (formal or informal transcripts accepted)
- 4. One letter of recommendation (from an undergraduate faculty member or advisor)

Application Submission Instructions

All required components of this application must be completed and sent in one email electronically or mailed as one packet and <u>received no later than Saturday, April 26, 2025.</u> Letter of recommendations may be included with the applicant's submission or provided separately by the recommender but must also be received to the address by due date.

Selection Process

The Friday Forward Fellowship will accept up to 10 students into the program each school year. Friday Fellows will be selected by a committee comprised of attorneys and Arkansas law school administrators and/or faculty members.

Candidates chosen for the 2025 Friday Forward Fellowship will receive notifications by email no later than Wednesday, April 30, 2025. It is imperative to provide a functional email address. Those selected for the program are required to formally accept the Fellowship by responding through email, phone, or letter. Contact details will be provided in the email/letter. Responses must be received by May 1st, 2025 to be considered valid.
